HEERF #3-Student Portion Reporting

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the HEERF Act to provide Emergency Financial Aid Grants to students.
 - a. *HEERF #3 Certification and Agreement was signed on 3/20/2021.*

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
 - a. *HEERF #3 was submitted to grants.gov for CCIU Practical Nursing Program to receive \$245,462.*
 - b. *HEERF #3 was received in CCIU PNP's G5 account on 6/10/21 (P425E203710).*

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the HEERF Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).
 - a. *HEERF#3 was disbursed in full to students on 1/26/2022.*
 - b. *All the HEERF#3 funds, \$245,462 were disbursed.*

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the HEERF Act.
 - a. *HEERF #3 funds, \$245,462 was divided equally to the 60 students who applied and were eligible for the grant.*
 - b. *Each student received \$4,091.04; Each student was sent a check via USPS on 1/26/2022.*

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the HEERF Act.
 - a. *60 students received the grant.*

 - a. *All current classes received an email with the details (see #7).*
 - b. *Funds were divided equally as felt that all applicants were financially impacted by COVID-19.*
 - c. *Students needed to:*
 1. *Submit an application*
 2. *Be Title IV eligible (rule relaxed on 5/21/20 per DOE that Title IV Eligibility no longer enforced, thus two additional students qualified).*
 3. *Demonstrate financial need*
